C. CAN Membership discussion:

Janet Brett transferred three CAN Membership Applications to Dori Luzzo-Gilmour that have been vetted by BFT. It was agreed that Applications will be received until October 15 before CAN Recruiting Committee interview Applicants.

6. NEW BUSINESS:

A. BFT presentation regarding status of safety and security standards and policies considering recent active shooter (pellet gun) in Pasco. General Manager Rachelle Glazier

1. Pasco Police have not identified a suspect for the pellet gun incident in Pasco.
2. Training is close to three years behind schedule for refresher courses, but a plan is in place to bring them up to date within approximately one year.
3. Incident de-escalation training is the top priority, with active shooter / drug use / emergency incident training following.
4. Driver / passenger safety due to long hours being worked by drivers is a concern and 10 DAR drivers are being hired in October to start training.

B. BFT Board of Directors meeting report – CAN Member Mathew Howie

BFT Meeting Notes from Mathew Howie:

Dial-A-Ride Driver spoke about being disappointed in the lack of reaction the Board had after the "active shooter situation" and about the ongoing shortage of DAR drivers

Many drivers are working 7 days a week.

DAR is down to two dispatchers.

Driver also felt the recent fair enforcement was placing unequal burden on DAR riders not otherwise extended to regular routes.

Dial-A-Ride Driver stated that the only way they can get a day off work is to call in sick. Recently, 6 drivers called in sick on the same day.

Fixed Route Driver addressed the lack of restroom facilities on a number of routes. A number of customers are going behind landscaping or parked vehicles

Dial-A-Ride Driver complained about dispatch shortage leading to a decline in service.

Dial-A-Ride Driver mentioned she had 450-hours of overtime just this year.

STAFF REPORTS AND OPEN DISCUSSION

1. Finance - Budgets and grant funding are moving in the right direction
2. Special Event Update - Fair had 22,000 rides
3. BFT Surveys - Are ongoing through the rest of the year. Some findings:
 - a. 65% of riders are English-speaking / 35% are Spanish-speaking
 - b. 70% of English-speaking respondents said they felt safe on BFT - those numbers were much lower for non-English-speakers
4. Trainings -Refresher CPR trainings for drivers are upcoming
- 5 Safety - Upcoming Inter-local agreement to have police presence at stops and on busses. Also working to secure video-surveillance equipment on busses. (Also, Board-led talk on having Narcan on buses.)
6. Driver Shortage - DAR is short drivers now with 10 on extended leave and 4 out on discipline
7. Restroom Facilities - Board-led talk about reserving portable restroom facilities on certain routes and requests BFT to get local business buy-in on restroom visits by riders

D. BFT Driver Training Program report.
Steve Davis, BFT -

A new DAR Driver Training Course will start in October and last approximately 9 weeks. Graduates will be starting work around January 1st.

Federal / State / and BFT requirements are taught so the training is more comprehensive than an ordinary CDL course, with emphasis on addressing rider needs.

As emphasized in Rachelle Glazier's presentation, safety and incident response will be treated in depth.

Medical physicals are required by each driver every two years.

New drivers are required to pass drug and alcohol tests prior to starting.

New driver training includes peer review of driving and rider interactions.
