A. Discuss status of the BFT 2024 Annual Service Plan and Public Comments. BFT Kevin Sliger made the presentation.

1. CAN Member Nayeli Aranda questioned whether there will be access to the new Pasco Vocational High School.

BFT Response: Yes, via Route 65.

- 2. CAN Member Ed Frost questioned whether the residences no longer to be serviced by Route 25 on Cottonwood can be advised in advance by leaving flyers on doors. BFT Response: That can be done along with other methods.
- 3. CAN Member Dennis Kreutz questioned whether the budgeted vehicles and hours shown on the presentation slides reflected Route 50 additions.

 ACTION REQUIRED BY BFT: BFT Response: Believe so but will double check.
- B. BFT Report discussing how the Connect Service works: by BFT Kevin Sliger.
 - 1. What determines eligibility to ride: BFT Anyone can use the service.
 - 2. Cost of service to riders, are BFT Passes honored: BFT Yes, or \$1.50 per ride.
 - 3. Where are the stops for residences, for destinations: BFT Varies on schedule. Not determined until the ride is booked.
 - 4. Are the vehicles ADA Compliant: BFT currently only two are ADA Compliant.
 - 5. BFT stated that rides from Tri-City Park-n-Rides to Airport is coming.
 - 6. BFT stated that rides are available for destinations within \(\frac{1}{2} \) mile of fixed route.
- C. BFT Board of Directors meeting report by CAN Member Dori Luzzo-Gilmour:
 - 1. There was a retiree with 30 years of service at BFT.

- 2. Several BFT Drivers spoke out about an employee that was terminated that they would like the Board to look into giving a second chance.

Dori and Dennis have reviewed the new applications, went over the pertinent information in the meeting with Frank Cuto, and directed by Chairperson Ed Frost to proceed with interviewing three of the Applicants.
