

Citizens Advisory Network Meeting

Wednesday, May 31, 2023 – 6 p.m. Ben Franklin Transit Administration Building GM Conference Room

MINUTES

1. Convene

Ben Franklin Transit (BFT) ADA Community Liaison Supervisor Brandy Arojo called the meeting to order at 6:03 p.m.

2. Roll Call

3. CAN Member Introductions

CAN members and staff went around the table and introduced themselves.

4. CAN Officer Nominations/Appointments

After a brief discussion, CAN members agreed they wanted to fill the officer positions at this meeting.

Dori moved to appoint Ed Frost as chair; Dennis seconded the motion, and it was agreed upon unanimously.

Frank moved to appoint Dori Luzzo Gilmour as vice chair; Ed seconded the motion, and all agreed unanimously on the appointment.

Dori made a motion to appoint Dennis Kreutz as recording secretary. Frank seconded the motion, and it was agreed upon unanimously.

5. Old Business

a. Reviewed Standing Rules of the CAN

b. Currently nine members are seated on the committee

c. Student representative suggestion

Ed believed this would require Board approval, and Janet agreed to follow up with General Manager Rachelle Glazier. This will be discussed in the fall when school is back in session.

d. Outreach to community members that use BFT economically

The group agreed they would like to have someone who can only afford bus transportation as a member.

e. Outreach to minority communities

CAN members would also like Hispanic representation, no-choice riders, choice riders, and super riders to have a voice at the table.

Ed suggested the next CAN meeting include a brainstorming session on various groups and their gatekeepers/access and how to get ahold of them.

Ed asked that Planning put together a presentation with information on the June 18 service changes. Ed would like the materials to go out one week prior to the meeting date.

f. CAN Meetings Day/Time

CAN members discussed their availability and agreed to move the meetings to the fourth Monday of each month at 6 p.m.

6. New Business

a. Discussion of proposed revisions to Standing Rules

Dennis proposed revisions to the CAN Standing Rules dated 7/13/2017. These will be discussed at the next meeting after members have had a chance to review them. Revisions will need to go to the BFT Board of Directors for approval.

b. CAN members attending BFT Board meeting for recognition Members discussed the possibility of attending a Board meeting; when the revisions to the Standing Rules item is on the agenda for approval would be an option.

c. Discuss significant policy decisions as they relate to the CAN, such as:

i. Major service changes

CAN members pointed out that they had never seen any notices about public meetings to discuss service changes. This will be communicated to Marketing.

- ii. Fare policy/price changes
- iii. Budget adaptations/changes
- iv. Electric vehicles/associated infrastructure
- v. Website upgrades
- vi. Ridership
- vii. Customer service plans

viii. Option to Zoom

The option to use Zoom to attend the meetings remotely was discussed. CAN members agreed in favor of a hybrid meeting, with in-person attendance encouraged, but Zoom available as an alternative.

d. Transportation barriers

e. Accessible stops

i. Dayton Street

ii. Columbia Basin

Bernie advocated for these stops to be made accessible. Braille signs would be greatly beneficial. Blind citizens are not using the fixed route system out of fear.
