3. COMMENTS BY GUESTS:

CAN Candidate Vaness Pruitt commented on her desire to be on the Citizen Advisory Network in order to advocate for para-transit accessibility for vision impaired and that she has experience with other agencies.

CAN Candidate Ulises Navarro commented on wanting to make more potential riders in the Latino community aware of BFT services.

CAN Candidate Brooklyn Hufstader said she is looking forward to attending the meetings in person and excited to bring some of the experiences she has gained as a student using Public Transportation.

5. OLD BUSINESS:

Chair, Ed Frost

A. QR Codes have been implemented on BFT signage at Transit stations and placards on DAR and Fixed Route Coaches per the recommendation of the CAN.

Dennis Kreutz noted that the QR Codes don't lead to the same information that is shown on the associated signage. Also, that the information displayed by using the QR Codes is not usable by visually impaired if read back in TEXT Format.

BFT Report: Kevin Sliger reported that increased compliance will be done during 2024 rollout of new signage.

6. NEW BUSINESS:

Chair, Ed Frost

 A. BFT Social Media Manager Brittany Nelson presented the following BFT Videos: Week Without Driving How To Rack Bike on BFT Coach Using Connect Services

CAN Members discussed how positive the videos are and appreciated learning about new services such as the Bike Repair Stations located at some Transit Centers.

B. BFT ADA Eligibility Supervisor David Para discussed how eligibility requests are handled by BFT and answered questions regarding Dial-A-Ride Eligibility Requirements.

Question by CAN: If a determination is made by BFT that a Fixed Route Stop is not wheelchair accessible is that determination then addressed with all Riders that would use that Stop?

BFT Answer: No, other Riders Eligibility are not modified because of that determination, each Rider's Eligibility is done separately based upon their situation.

Question by CAN: Citing an Eligibility Review wherein it was determined that power wheelchair was not waterproof the original Eligibility Denial was overturned to allow DAR Eligibility when rain is forecast, has that Eligibility automatically instated for other Riders using power wheelchairs?

BFT Answer: No, other Riders Eligibility are not modified because of that determination, each Rider's Eligibility is done separately based upon their situation.

Question by CAN: It appears that the purpose of the Eligibility Determination is to preclude many Riders from using DAR, is this the BFT Policy?

BFT Answer: No, the goal of BFT is to allow as many Riders as possible to meet the Eligibility Requirements for DAR. It was stated that since Fixed Route transportation is less expensive per ride it is advantageous to BFT to have Riders use Fixed Route instead of DAR when possible.

C. BFT Manager of Paratransit Operations Megan Schmidt answered questions about Paratransit On-line and Call-in Reservation Services.

Megan explained how scheduling is done when calls are placed to BFT, or done online.

Question by CAN: Is BFT considering allowing same day reservations if schedule allows?

BFT Answer: No, that is not being considered.

Megan discussed BFT Rider Policy.

D. Report from CAN Recruitment Committee: Dori Luzzo-Gilmour

Dori Luzzo-Gilmour reported that three prospective members were interviewed and recommended for CAN Membership.

Ed Frost asked for a vote of the CAN Members to approve all three candidates.
