#### **Background**

Ben Franklin Transit (BFT) is seeking approval to increase the CEO's approval limit of \$100,000 and enter into a contract for improvements to the southwest entrance of the Benton County Fairgrounds, located on Fairway Street in Kennewick, Washington (Exhibit A). The Benton Franklin Fair & Rodeo is a yearly event that BFT serves and supports every summer. The southwest entrance that transit operates is in need of improvements to enhance Americans with Disabilities Act (ADA) accessibility and functionality. This proposed project qualifies as a passenger amenities upgrade and will be funded through local funds.

#### **Description of Work**

As part of the scope, the existing fencing in the area will be demolished and replaced with new fencing that allows for a more efficient layout and expanded space for bus maneuvering and staging (Exhibit B). The passenger loading area will be significantly expanded and resurfaced to accommodate additional bus bays, improving overall passenger flow and operational efficiency. These improvements aim to improve ADA access and streamline transit service access to the fairgrounds and enhance overall rider experience. A high-level conceptual plan is provided in *Figure 1* to illustrate the general layout and design intent. This plan will be further refined throughout the ongoing design and engineering process, in close coordination with Benton County and other project partners.

#### <u>Timeline</u>

BFT is actively working with project engineers (KPFF), Benton County, the City of Kennewick, and Benton Franklin to expedite the planning and implementation of this project. The goal is to complete the improvements in time for this year's Fair & Rodeo, which is planned for August 19<sup>th</sup> through the 23<sup>rd</sup>. Staff members are coordinating closely with all stakeholders to ensure the project moves forward quickly and efficiently to meet the seasonal deadline. We are asking the board to give authority to the CEO to enter into a contract worth up to \$500,000 to continue to move quickly with this project.

#### **Background**

Current wash systems were installed in 2007 and have exceeded their useful life. FTA Useful Life Standards list bus washing equipment as having a 10-year life expectancy. Breakdowns are costly and cause delays in workflow. Improper detergent dispensing can cause damage to vehicle finishes and lessens the useful life of consumables such as brushes. Additionally, outdated wash system design increases the possibility of vehicle damage.

Ben Franklin Transit has the option to utilize Washington State Contract #25923 to purchase a Westmatic 4 Brush Transit Master Drive Through Wash system. This new wash system will be capable of washing all vehicle types, allowing BFT to repurpose the former small vehicle wash bay for use as an IT bus upgrade bay. BFT will request an invitation for bids to have the bus wash system installed. BFT will bring a memo and resolution for recommendation to award to the Board of Directors in July or August.

The increased funding amount for the project will cover both the cost of the lift and installation, as well as the additional scope of work required to renovate the current small vehicle wash into a usable IT bus bay.












### Weekday Ridership Increases by Time of Day


